

EmpowerU 8th Congressional District Candidate Interview/forum

Format

Approximately two hours are planned for this forum: 90 minutes of question and answer, posed by the panel and 30 minutes of select questions from the audience. The forum opens with each candidate introduced by the moderator (EmpowerU is working to secure a professor of political science with knowledge of the 8th district to serve as moderator.)

Each participant is asked to provide a short bio/introduction (paragraph) to be read by the moderator. A three-minute closing opportunity will be afforded each candidate to offer any comments/qualifications and/or explain why they would be the best choice to represent the voters of the 8th district.

Questions will be posed by a panel consisting of three individuals—each versed in a specific area of government policy.

Candidates will have up to two minutes to answer each question. A timekeeper will use paddles to alert when 30 seconds remain (yellow) and when time expires (red). Note, this forum is not a debate, rather a candidate interview for the congressional seat.

The moderator has the discretion to ask the panelists if they have a follow-up to a candidate's answer. They may also comment or ask a question to clarify a response.

Dear Ms. Thomas,

I didn't realize I was to answer on a separate sheet of paper until I got to the very end of the questions. I thought there wasn't very much space. Sorry about that.

- 1. There are many agencies in our Federal Government that do the same or similar jobs that could be merged, and in many cases completely eliminated. The main agency that I can think of that I would eliminate would be the Department of Education. I believe in localized Education at the State and local levels, the Federal government does not belong in our educational system.
- It is my belief that the Federal government can keep America safe without infringing on our freedoms, but to do so means that we are going to have to stop being politically correct. If the individuals who are a threat to our National Security, are clearly identifiable, by their religion, ideology, the Country they are from, names skin color, etc., then that is what should be used to eliminate and prevent the threats. It is only common sense, and then you go after them in a legal manner to implement surveillance of them and their activities that are a threat to us here at home or our National Security.
- Yes, there should be term limits on both house of Congress. For Senators, 2 four year terms, and for Representatives, 4 two year terms. NO ONE should make a lifetime career in Congress.
- People who have entered the Country illegally should not have a special path to Citizenship, when we have people trying to come here legally, and doing everything the way it should be done. Those who have come here by breaking the law should not be rewarded over those who have or are trying to come to the United States legally. It's not fair to them, or to us.
- No justification for coming here illegally.
- The United States should stay out of the internal affairs of other Nations, unless they are being attacked and we are there ally and have a duty to step in and help, but it is not our job to Nation build, or stick our noses in other Countries business. There is an exception though, if it involves our National Security or if a Country is committing genocide.
- I do support a voucher program or tax credit program for parents to send their kids to school wherever they want to send them. In fact, I think that the average amount of money we spend per pupil in the U.S. which is around \$13,000.00 should be given to the parents to send their children to whatever school they wish. This would make public schools better by being in competition for their students, and the kids get a better education.

I do not support Common Core. It is dumbing our children down, and indoctrinating them into beliefs that I do agree with, nor do their parents. It should be up to the parents what their children are learning in school, not bureaucrats.
